Sir/Madam,

I am directed to refer to the above-mentioned letters on the subject cited above and to convey approval of Central Provident Fund Commissioner/ President, Central Staff Welfare Committee, Employees' Provident Fund to enhancement of the amount of Ex-gratia Death Relief Fund from Rs. 8.00 Lakh to Rs. 8.80 Lakh. The, ex-gratia Death Relief Fund. of Rs. 8.80 Lakh (Rs. Eight Lakh Eighty thousand only) shall be paid to the family members (nominee or legal heirs) of the deceased employee of the Central Board from the Welfare Fund.

2. The instructions shall come into force with effect from 01.04.2024. The additional DRF amount of each death case (date of death is on after 01.04.2024) has been allotted to the respective Zonal Office. List of eligible cases who will additional DRF amount is attached as **Annexure-I**.

3. The additional DRF amount as per the above rates shall be paid to the family members (nominee or legal heirs) of the deceased employee immediately without any delay.
